



Policy For RPAYC Centreboard Storage Racks

1. Racks are the property of the Club and are not transferable when boats are sold
2. When new boats arrive they will be put on a waiting list if no rack is available – application forms are available at Reception.
3. Members are entitled to a rack spot for a twelve-month period from 1 November to 31 October (or part thereof).
4. Billing for rack spaces will be on a monthly basis. One month's notice of termination of agreement will be required.
5. Members who are registered for the season and have a rack space must use their vessel on a minimum of four scheduled race days. If a scheduled race day coincides with a class state championship, sailing in that event will count towards a scheduled race day if the vessel is representing RPAYC. Failure to keep up this level of usage may result in loss of rack space.
6. At the beginning of September the Waterfront Office will write to each rack space holder asking if they want their rack space renewed for the following year. The renewal notice will accompany the new season centreboard registration form.
7. If a member, with a current rack space, is not signing up for the new season the rack space cannot be renewed and the member will only be allocated a rack space should there be any available after all centreboard registrations for the new season have been received. Renewal in this situation will be on a month-by-month basis. The member who has a rack space and is not registered to race with centreboard may lose that rack space to a member signing up for the sailing season and wanting a space.
8. Space allocation will be determined by RPAYC management In accordance with this policy and ratified monthly by the Centreboard Committee.
9. Members using their boats frequently (ie on average more than 2 times per week during the sailing season) may request a more convenient rack space. Such requests are to be made to the RPAYC management on the appropriate form.
10. The Centreboard Committee may advise RPAYC management to relocate members' boats when usage is minimal. In such cases, RPAYC management will advise the member(s) concerned of the decision of the Centreboard Committee to move their boat.
11. All boats in racks must, at all times, represent RPAYC when competing. Under no circumstances can boats sail for other clubs.
12. All boats stored in racks must display RPAYC on their stern, no exceptions.
13. All boats stored in racks must be skippered and crewed by RPAYC members. The Club draws Members attention to the Racing Rules for Sailing, Rule 55, skippers or crew who race more than 3 times per year shall be members of YA.
14. Boats must be returned to their allocated space after use. Any boat left on the lawn after Sunday evening (other than during Regattas) will be returned to their allocated space and a movement fee will be charged to the member's account. Where there is no allocated space, the boat will be moved to the Crystal Bay Car Park and a movement fee will be incurred. If the owner of the vessel can be identified, the Club will make every effort to contact the owner and advise of the movement. Please be aware that this is an unsecured space and the Club will not be responsible for any theft or damage that may result.
15. Boats and their rigs can only be left in their allocated space. All rigs must be packed away by end of weekend.
16. No trailers are to be left in the lower level car park or lawn area at anytime and must be taken to the top level of the main car park (except Saturdays) or the Crystal Bay Car Park.
17. The RPAYC and members are not responsible for vessels and vessel equipment stored at the Club.
