

**Risk Notice**  
**Civil Liability Act 2002**

Sailing is a sport that involves interacting with the uncontrollable and difficult to predict elements of nature, and therefore involves a degree of risk. Many of the risks inherent in the sport are intuitive. Without seeking to list all possibilities the following are brought to your attention:

- There can be a significant risk of bruises, cuts, scratches and other injuries resulting from contact with the boat or collision with other boats. Flapping sail, or unanticipated changes in wind direction or in the direction of the boat can cause a spar to bump the head or other part of the body or cause a rope flick injury. These injuries can occur both afloat or while near a boat on land.
- When launching or coming ashore, hard surfaces below the high tide line can become slippery, resulting in slip and fall injuries. Oysters and other sharp marine creatures can also grow on these surfaces. Stinging jelly fish or other marine stingers may be present in the water. Sharp objects can be hidden in sand or weed below the water which can cut or pierce feet or other parts of the body. Proximity to the elements makes it more likely for nails or splinters to be raised in wooden decks and floors and these can also cause foot injuries and trip hazards. The wet feet of sailors can make surfaces slippery.
- Because of reflected glare, sunburn will occur more rapidly than normal on unprotected skin. Dehydration or hypothermia can occur in those who do not heed and prepare for the conditions.
- Most injuries are relatively minor. However on occasions the injury can be more significant.
- When windsurfing/SUP on inshore waters, serious injuries of the type that can cause permanent disablement or even death are statistically very rare but can and do occur. As with any water sport, the possibility of drowning is also present. While for many sailing activities a support boat may be present, the driver cannot be everywhere at once, cannot observe every incident that occurs and may not always recognise an observed incident as being a serious one requiring immediate response. First aid or medical assistance may be not available.

I have read and understood the above risk warning and I agree that I participate in the sport of sailing at my own risk and I acknowledge that neither the Royal Prince Alfred Yacht Club ("Club") nor any official, instructor, volunteer or member shall be under any liability whatsoever for the death or bodily injury, loss or damage which may be suffered or incurred by me or the minors for whom I am responsible.

I also acknowledge that neither the Royal Prince Alfred Yacht Club nor any official, instructor, volunteer or member shall be under any liability for any loss or damage to personal property or assets used under the Windsurfer/SUP Lease Scheme which may be suffered or incurred by me or the minors for whom I am responsible.

I understand that I or the minor for whom I am responsible may be photographed while participating in activities conducted by the Club and I hereby give permission for the use of my name or the name of the minor for whom I am responsible to be used in all forms of media for the promotion of the Club.

**I have read and understand the Guidelines & Conditions for the Windsurfer/SUP Lease Scheme and agree to:**

1. Maintain and repair to a suitable standard the boat I have been issued.
2. Participate in training and/or centreboard racing during the lease period.
3. A Lifejacket of Level 50 or TYPE 2 shall be worn at all times.
4. In the event of damage cover the cost of repairs up to \$500 for each event causing damage.
