NOTES TO APPLICANT

1. Each candidate is required to complete an application form.
2. Royal Prince Alfred Yacht Club (the **Club**) is committed to protecting the privacy of your personal information in accordance with the Australian Privacy Principles. Please refer to the Club's Privacy Policy on the RPAYC website www.rpayc.com.au.
3. If the candidate is an owner (solely or in part) or the charterer of a Boat (defined in Australian Sailing's Racing Rules of Sailing Addenda A, Part 2 as a vessel greater than 3 metres in length, except 'Off the Beach Boats') the candidate **must** apply for Full Membership **and** complete the Club's **Additions to the Register of Vessels Form**. The candidate will be added to the Club's Register of Vessels. *Note:* a determination by the Board that a particular vessel, or class of vessel is, or is not, a Boat for the purposes of this definition shall be binding and final.
4. A Spouse means the husband, wife or partner of a member accepted by the Board to be living in a stable domestic relationship with a member or candidate for membership.
5. A Family means a group of two or more members who are related to each other either as parents, spouses, domestic partners, step-parents, guardians, children, step-children or any person under guardianship of one of the other members referred to in this definition.
6. A credit card surcharge will not be charged for the joining fee and initial subscription. The credit card details provided will only be used for these fees.
7. No refund will be provided for members seeking to resign after being approved as a member. If a member has elected to pay the annual subscription fee by direct debit instalments, the member is required to pay all remaining instalments for the duration of the Club's financial year in accordance with the Direct Debit Terms and Conditions.
8. Each candidate for Full Membership and General Membership, except a General Member applying to be a Spouse or Youth, requires a proposer and seconder to support their application.
9. The proposer and seconder of this candidate must:
 - a) Be either a Full Member or General Member of the Club of **not less than twelve months'** standing;
 - b) Have known the candidate personally for a period of not less than twelve months;
 - c) Be confident that the candidate is of good fame and character, and they have expressed the intention to participate in the Club's sailing activities;
 - d) Respond to any further questions which may be raised by the Membership Committee or Board in relation to the candidature; and
 - e) Actively assist the candidate in meeting other Club members and participating in Club activities with a view to fostering a long, happy membership. Proposers and seconds will be invited to attend a New Members' evening function alongside successful candidates.
10. If the candidate is unknown to any members, the candidate may enclose **two** character references as an alternative to a proposer and seconder. Referees should know the candidate for a period of not less than twelve months. **Please use the Club's referee proforma**. Submission of references indicates to the Club the candidate's consent for the Club to contact the referees in relation to the candidate's suitability for membership of the Club.
11. The Club is required to provide Australian Sailing with a successful candidate's name, date of birth, postcode and email address to facilitate Australian Sailing membership. If elected, the candidate consents to the preceding personal information being provided to Australian Sailing.
